### **GENERAL RULES:**

- Fixtures and Draws made for the tournament by the Organizing Committee will be final and will not be changed except due to unavoidable circumstances.
- The Organizing Committee has the right to postpone any match if deemed necessary due to un-avoidable circumstances
- Forms will be available at our website www.tnmemorialtrust.org.
- Each team would submit a list of 15 (male or Female including officials) players along with latest photo. For matches played in that tournament, the team of 11 must be nominated from this list.
- Max. of 3 members of a team may be from 25 to 30 years of age and remaining all must have completed 30 years of age as on 1/3/2018. In case of dispute the decision of organizing committee would be final.
- In case of any change in the team list submitted the team would inform well in time to the organizing committee for approval.
- No spiked footwear shall be permitted while batting.
- Teams must report 30 minutes before commencing the match. If a team fails to report even after 15minutes of the scheduled time, the opponents will be given a walk over. By the term 'reporting' it is intended that the captain should handover the list of players, be ready for the toss and should be ready to take the field as and when the umpires want them to.
- Qualified and professional panel Umpires will be posted for this tournament. On the field during play, the decision of the umpires would be final and binding on all players.
- Balls will be provided by the organizers, the teams cannot use any other balls apart
  from those provided. Change of ball during play will be at the sole discretion of the
  umpires.
- First aid kits will be available to treat any injuries sustained while playing.
   T.N.Memorial Trust will not be responsible or be liable for any injuries.

- Players who are currently playing for First Class, T20, IPL or any State Level categories anywhere in India or abroad will not be permitted to participate in this tournament.
- Player registered under one team won't be able to participate from other team during the period of tournament. If any team found doing this the team would be disqualified from the tournament.
- It would be a 20-20 over a side tournament. The tournament would be played on league basis. Each team would get to play a minimum of 2 matches.
- Matches would be played on Saturday and Sunday only. Each team would be given an option of playing one day and night or one night match
- Each innings will be of 1 hr. and 20 minutes duration without any drinks break, followed by 15 minute change over between the innings.
- Light refreshments would be provided to each team during the break.
- Coloured T- Shirt will be provided to each team by the organizers which would be mandatory for players to wear during the match.
- In case of any dispute during the passage of play the decision of on field umpires would be final and be binding on both teams. No other objections would be entertained by the organizers
- In a single innings, each of the bowlers can bowl a maximum of only one-fifth of the total overs i.e. 4 overs in a total of 20 overs.
- If, and only if, each of the two teams has faced (or had the opportunity to face) five overs, will be a match deemed to have played.
- To calculate a team's net run rate, the average runs per over scored by that team is deducted from the average runs per over scored against it.

#### FIELDSMAN/BATSMAN LEAVING THE FIELD

If a fielder fails to take the field with his side at the start of the match or at any later time, or leaves the field during play:

- The umpire shall be first informed of the reason of his absence.
- He shall not thereafter come on to the field during the play without the consent of the umpire.
- If that fielder or substitute comes into field without the permission of the umpire and handles the ball before the ball becomes dead, 5 penalty runs will be awarded to the batting side and the ball will be declared dead ball.
- If he is absent for 8 minutes or longer, he shall not be permitted to bowl thereafter, until he has been on the field for at least that length of playing time for which he was absent.

#### **NO BALL**

- A bowler shall be limited to one fast short pitched delivery per over.
- A fast short pitched delivery is defined as a ball which passes or would have passes above the shoulder height of the striker standing upright at the crease.
- In the event of more than one a fastshort pitched delivery per over being bowled Main Umpire shall call and signal NO BALL on each occasion. To call a "NO Ball" for fast short pitched delivery will be the responsibility of the main umpire.
- If there is a second instance of the bowler being no balled in the innings for bowling more than one fast short pitched delivery in an over, the

Main umpire shall advise the bowler and his Captain that this is his final warning for the innings.

- Should there be any further instance by the same bowler in that innings, the umpire shall call and signal no ball and when the ball is dead direct the captain to take the bowler off forthwith.
- A Short Pitch delivery that passes above head height of the batsman and prevents him from being able to hit it with his bat by means of a normal cricket stroke shall be called a wide.
- One run will be awarded to batting team for every NO BALL & WIDE BALL in addition to number of runs scored on that ball.
- Any delivery, which passes or would have passed on the Full above Waist Height of the striker standing upright at the crease is deemed unfair, whether or not it is likely to inflict physical injury on the striker. The umpire at the bowler's end shall, call and signal 'No ball', and when the ball is dead, caution the bowler and issue a first and final warning. If the same is repeated by the same bowler in that innings then the Umpire will call that delivery No ball when the ball is dead and direct the Captain to take the bowler off forthwith and not allow him to bowl again in the innings. If necessary the over shall be completed by another bowler who shall have neither have bowled the previous over or part thereof nor be allowed to bowl the next over or part thereof.
- The umpire will report the occurrence to the other umpire, the batsman at the wicket and the Captain of the batting side. The umpire will also report the matter to the Tournament Committee who shall take appropriate action against the bowler and the Captain of the bowler concerned.

• In addition to the above delivery following a No Ball called for a foot fault—shall be a 'Free Hit' for whichever batsman is facing it. If the delivery for the Free Hit is not a legitimate delivery (any kind of no ball or wide ball) then the next delivery will become a Free Hit for whichever batsman is facing.

#### WIDE BALL

Umpires will apply strict and consistent ruling in-regards to this law to prevent negative bowling. One run will be awarded to batting team for every WIDE BALL in addition to number of runs scored of them.

#### LIMITATION OF FIELDSMEN

- At the instance of delivery, not more than six fielders on the Off-Side and not more than five fielders on the On-Side of the wickets shall be allowed. In the event of an infringement, the umpires shall call and signal "No-Ball".
  - A fielding restriction shall apply to the first 6 overs of each innings. During the Fielding Restrictions overs only two fieldsmen shall be permitted outside this fielding restriction area at the instant of delivery.
- During the Non-Fielding Restrictions overs, no more than 5 fieldsmen shall be permitted outside this fielding restriction area at the instant of delivery
- Protests, if any should be lodged only by the team captain or manager within one hour after the completion of the match with a fee of INR.2,500/-, refundable only if the protest is found to be valid.
- The tournament committee reserves the right to frame/ change/ modify any of the rules at any stage of the competition if found necessary.
- All other rules of ICC will be applied for each game.
